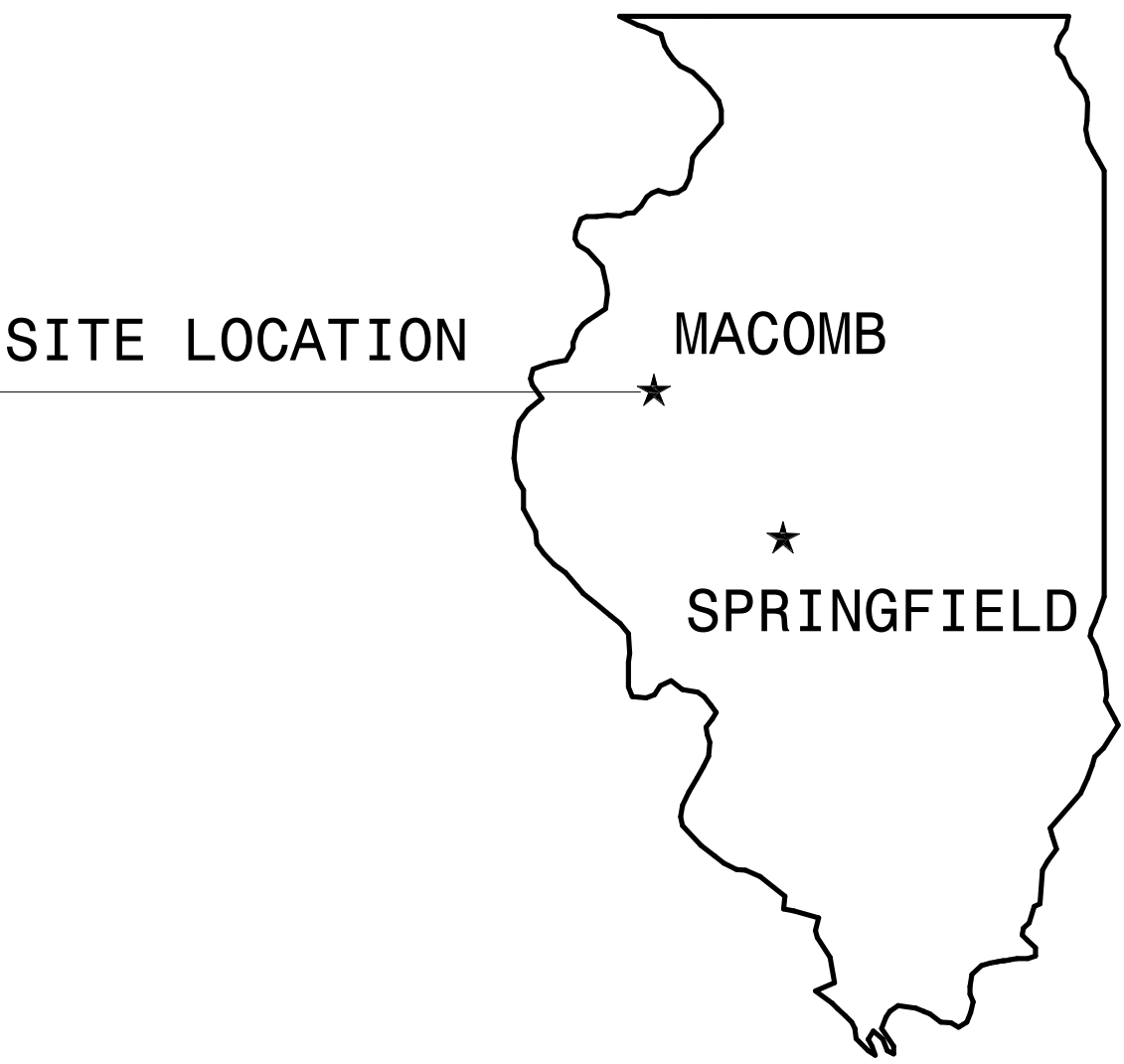

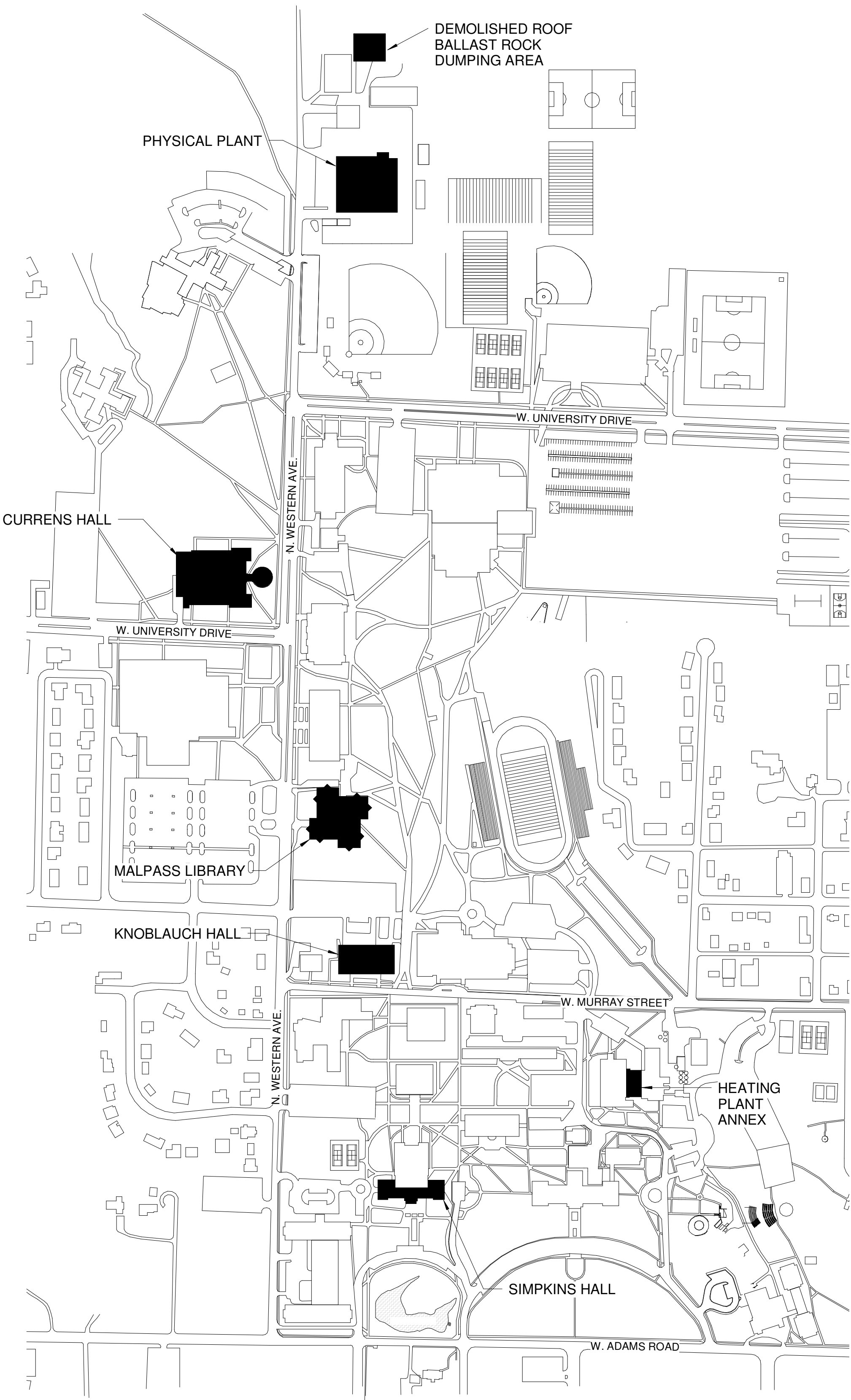

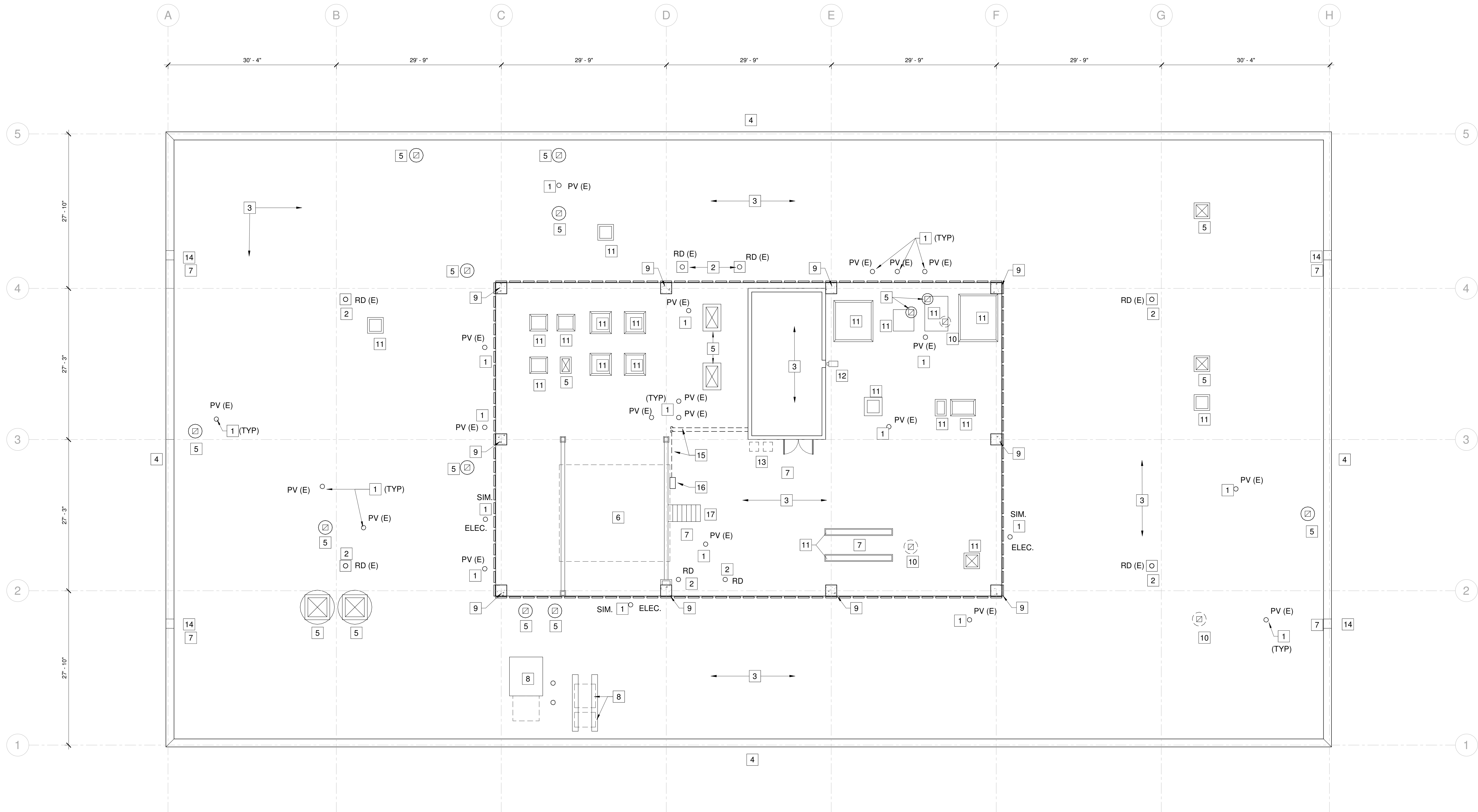

GENERAL NOTES

- 1 CONTRACTOR TO VERIFY ALL DIMENSIONS.
- 2 ANY DISCREPANCIES BETWEEN STATED AND EXISTING CONDITIONS SHALL BE REPORTED IMMEDIATELY TO THE ARCHITECT.
- 3 DISCREPANCIES OR CONFLICTS BETWEEN SPECIFICATIONS AND DRAWINGS SHALL BE MADE KNOWN TO THE ARCHITECT FOR CLARIFICATION.
- 4 THE CONTRACTOR SHALL BE RESPONSIBLE FOR PROTECTING THOSE AREAS TO REMAIN UNDISTURBED DURING CONSTRUCTION.
- 5 THE CONTRACTOR SHALL TAKE NECESSARY PRECAUTIONS, AS PER THE WRITTEN SPECIFICATIONS, TO MAINTAIN SAFETY AT THE CONSTRUCTION SITE, AND HE IS SOLELY RESPONSIBLE FOR SAFETY MEASURES. SCOPE OF DEMOLITION WORK

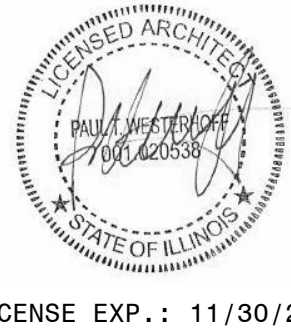
- DEMOLITION AND REMOVAL OF ORIGINAL ROOF MEMBRANE, ROOF BALLAST, ROOF DECK INSULATION, AND ANY EXISTING UNDERLAYMENT IN-PLACE.
- THE PHASE OF SELECTIVE DEMOLITION SHALL BE CLOSELY COORDINATED WITH REQUIRED ASBESTOS ABATEMENT ACTIVITIES. SEE SPECIFICATION SECTION 02 26 25.
- PROVIDE PROTECTION OF CERTAIN ROOF MOUNTED ITEMS THAT ARE TO REMAIN IN PLACE, IE., EXISTING ROOF HATCHES, MECHANICAL EQUIPMENT, ITEMS MOUNTED TO THE EXISTING BUILDING, CERTAIN GAS VENT PIPES, ETC.
- CERTAIN ITEMS TO BE REMOVED, REUSED AND REINSTALLED, IE., ROOF LADDERS, PLUMBING VENTS, PLUMBING PIPING, EXHAUST FANS, EXHAUST HOODS, AIR-INTAKE HOODS, RELATED DUCT WORK, MECHANICAL DEVICES, AND ELECTRICAL POWER DEVICES, AS NOTED ON THE PROJECT DRAWINGS.
A) VERIFY WITH OWNER IF OTHER ITEMS TO BE DEMOLISHED AND REMOVED ARE TO BE SALVAGED AND / OR REUSED.
- DEMOLITION ACTIVITIES SHALL BE PERFORMED TO MAINTAIN CONTINUOUS OPERATIONS OF THE EXISTING FACILITY. MINIMAL SHUT-DOWN TIME FOR EQUIPMENT IS REQUIRED.

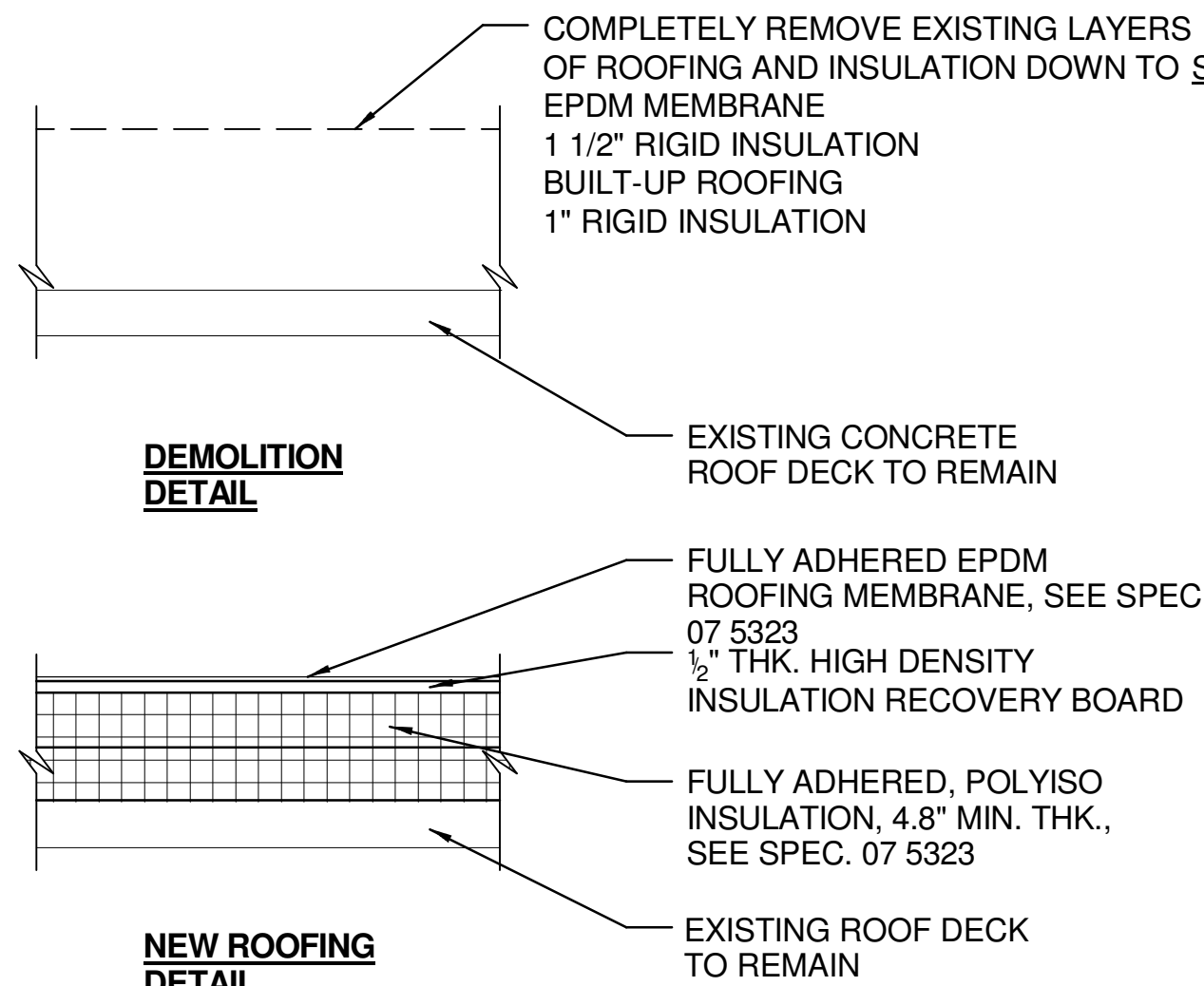

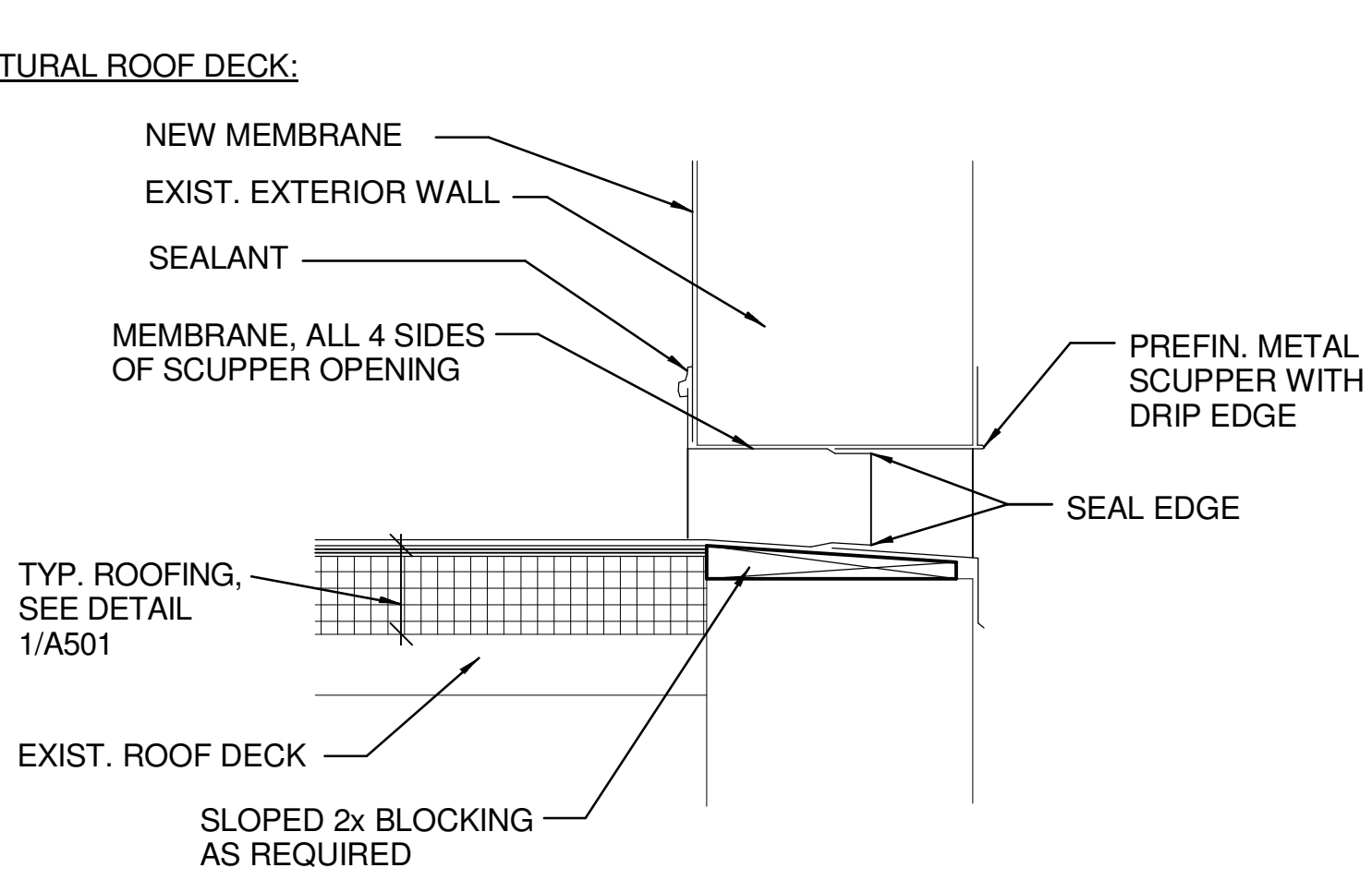

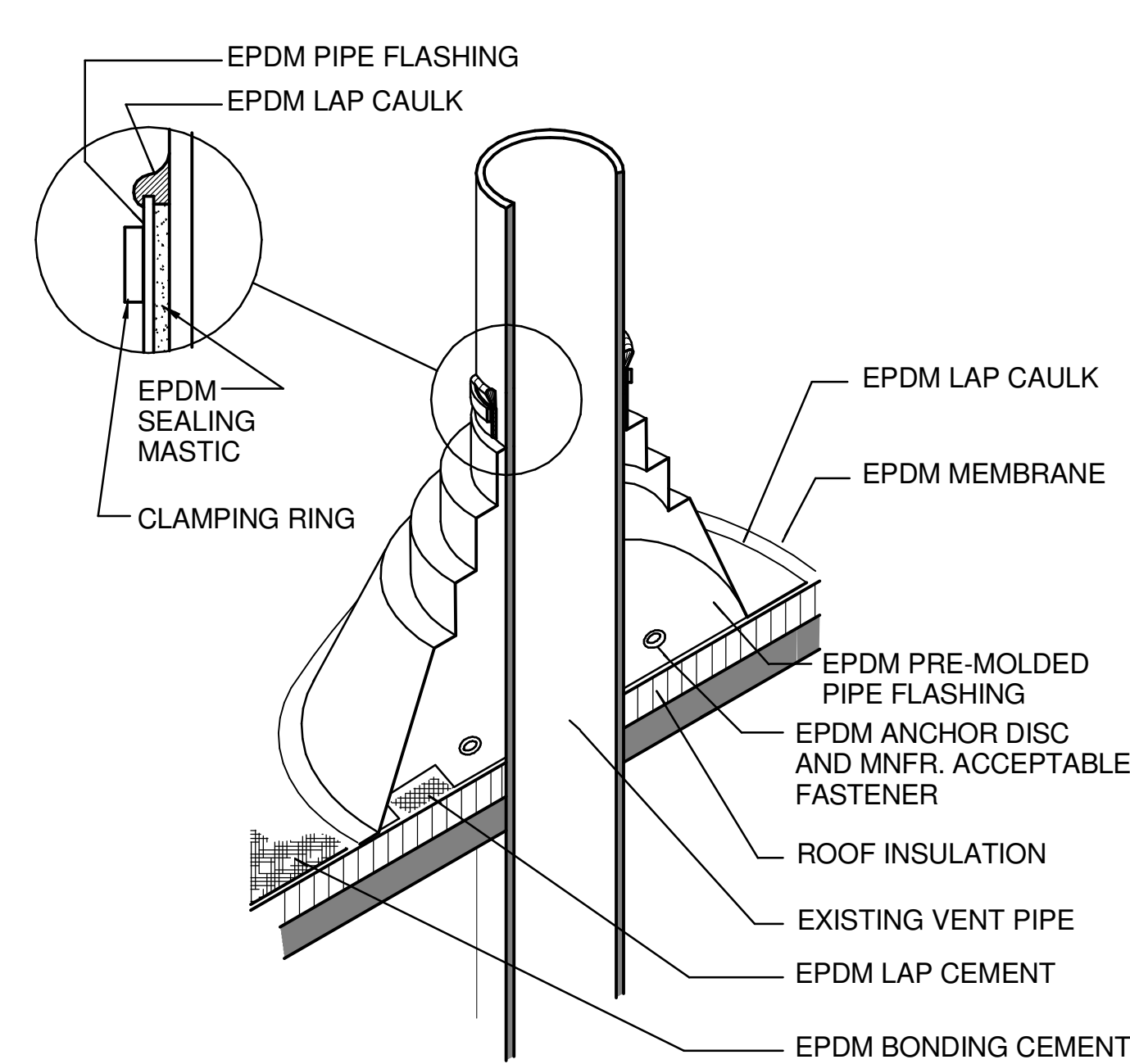

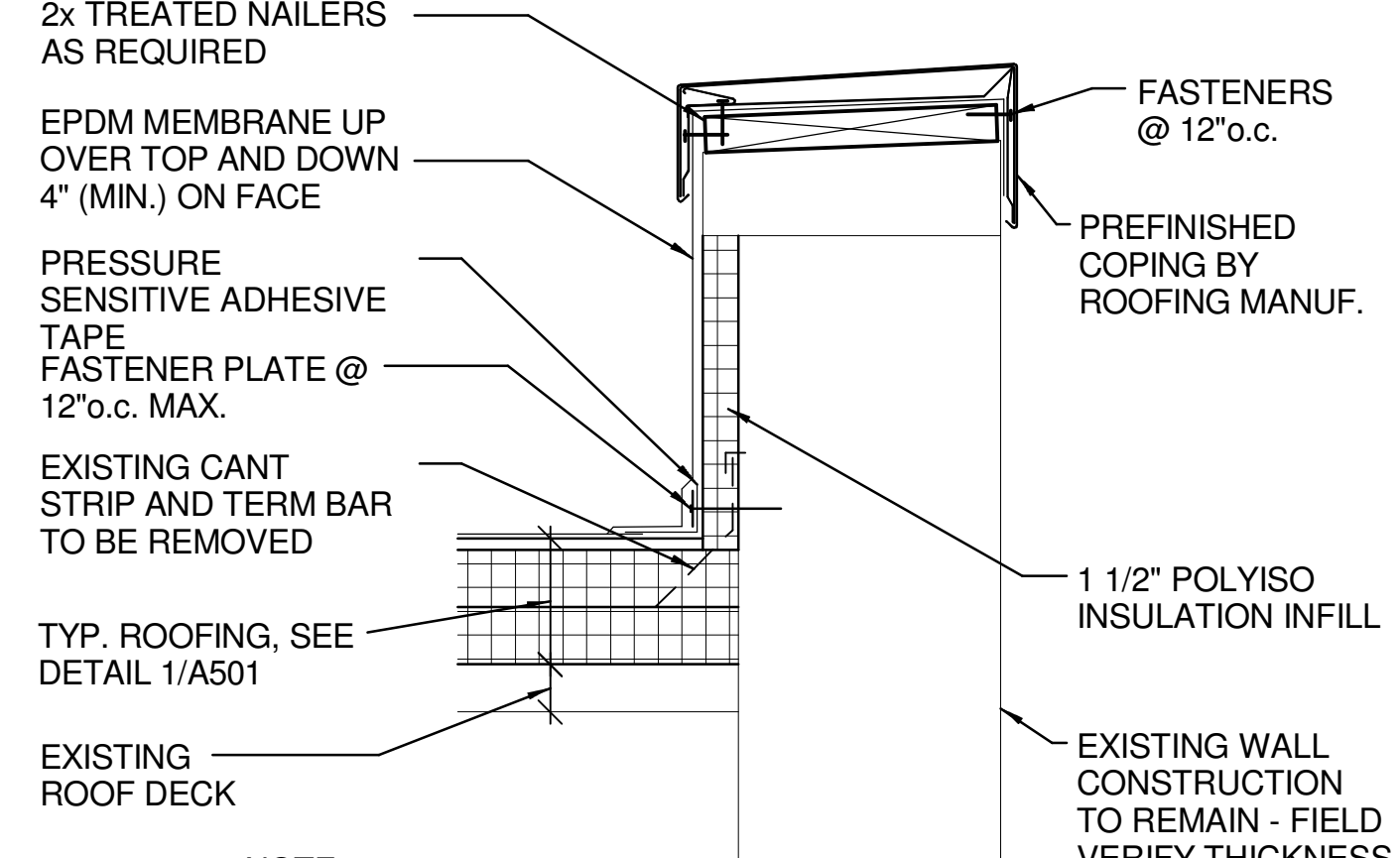
5 ROOF CURB DETAIL

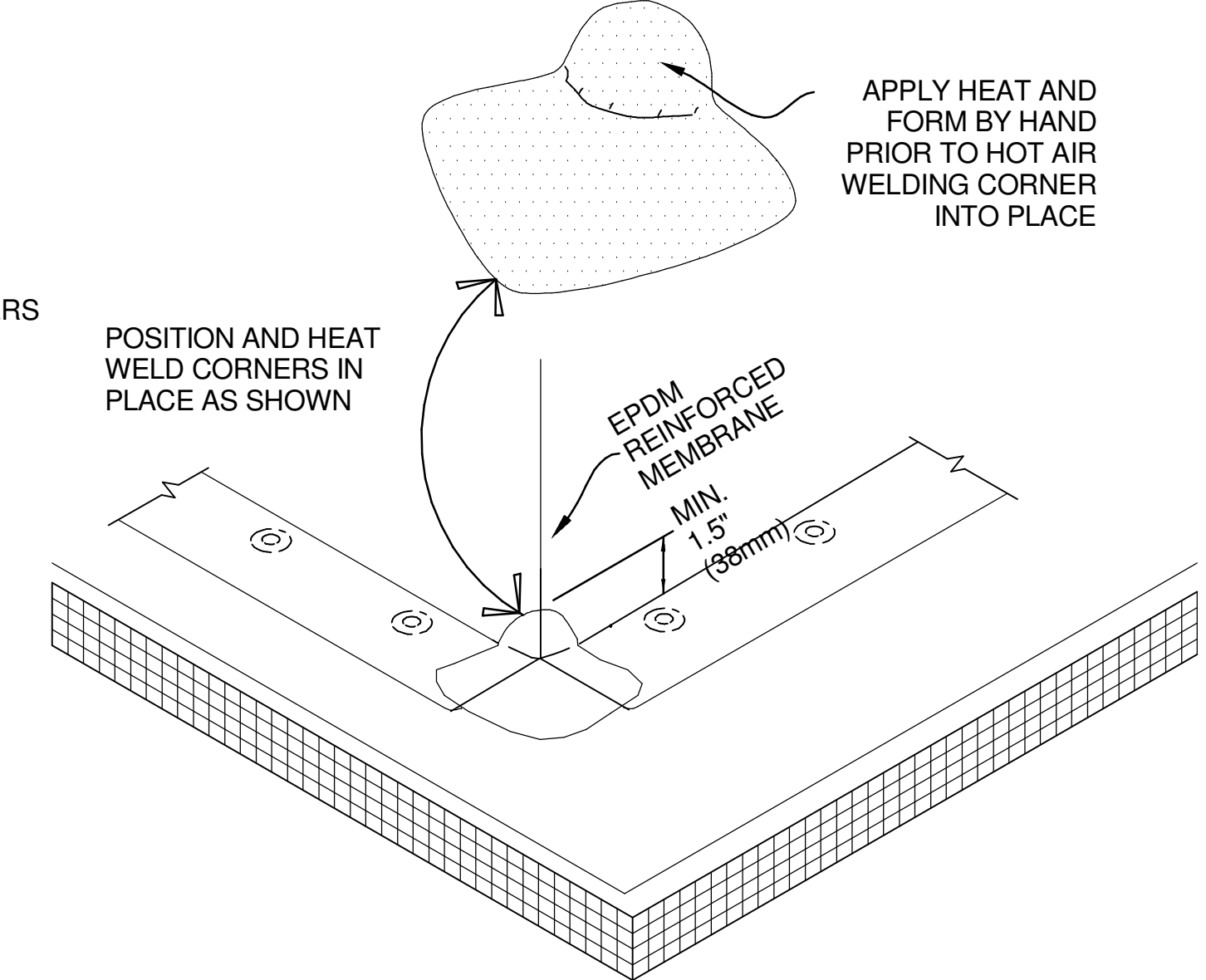


7 PLUMBING VENT EXTENSION

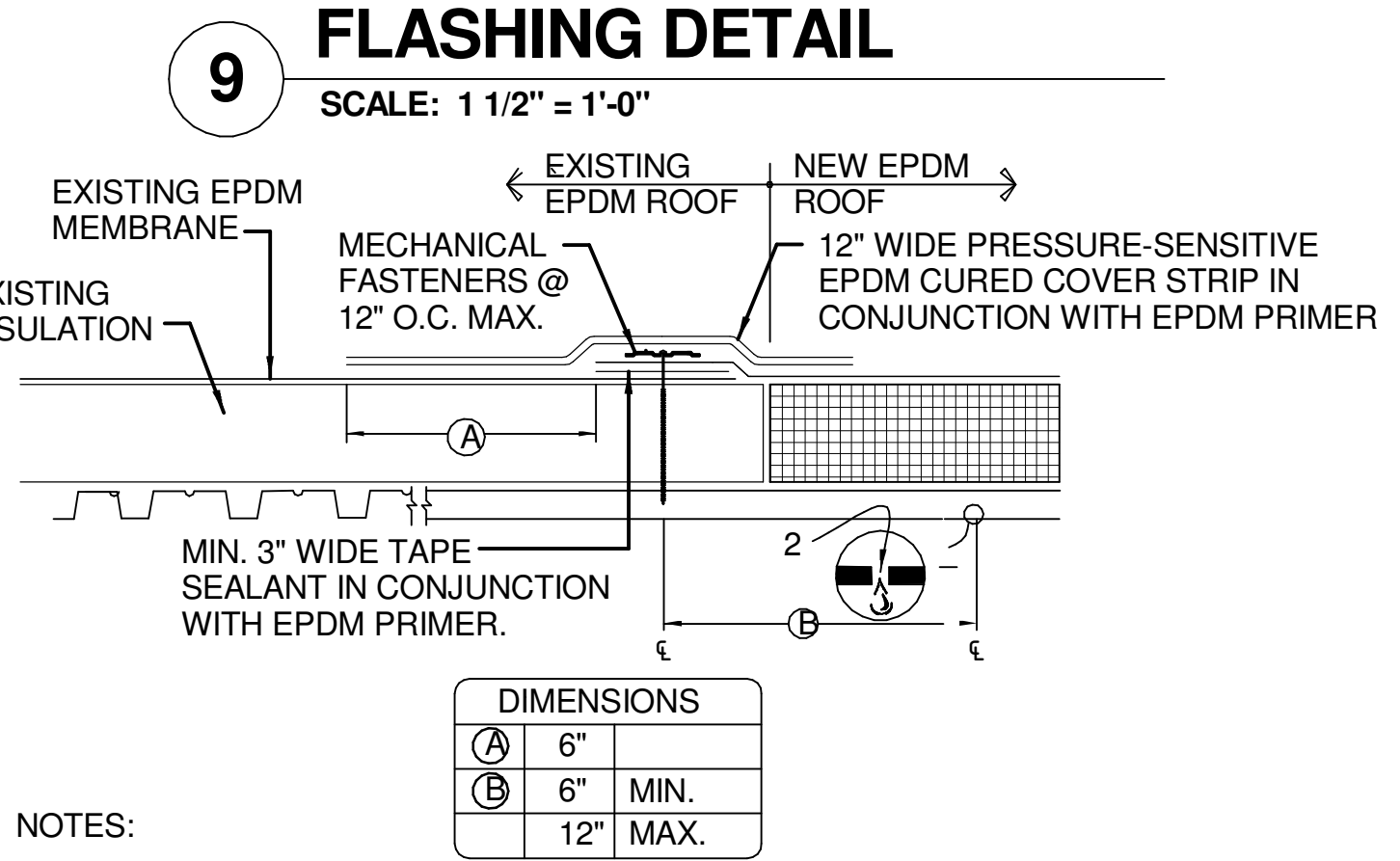

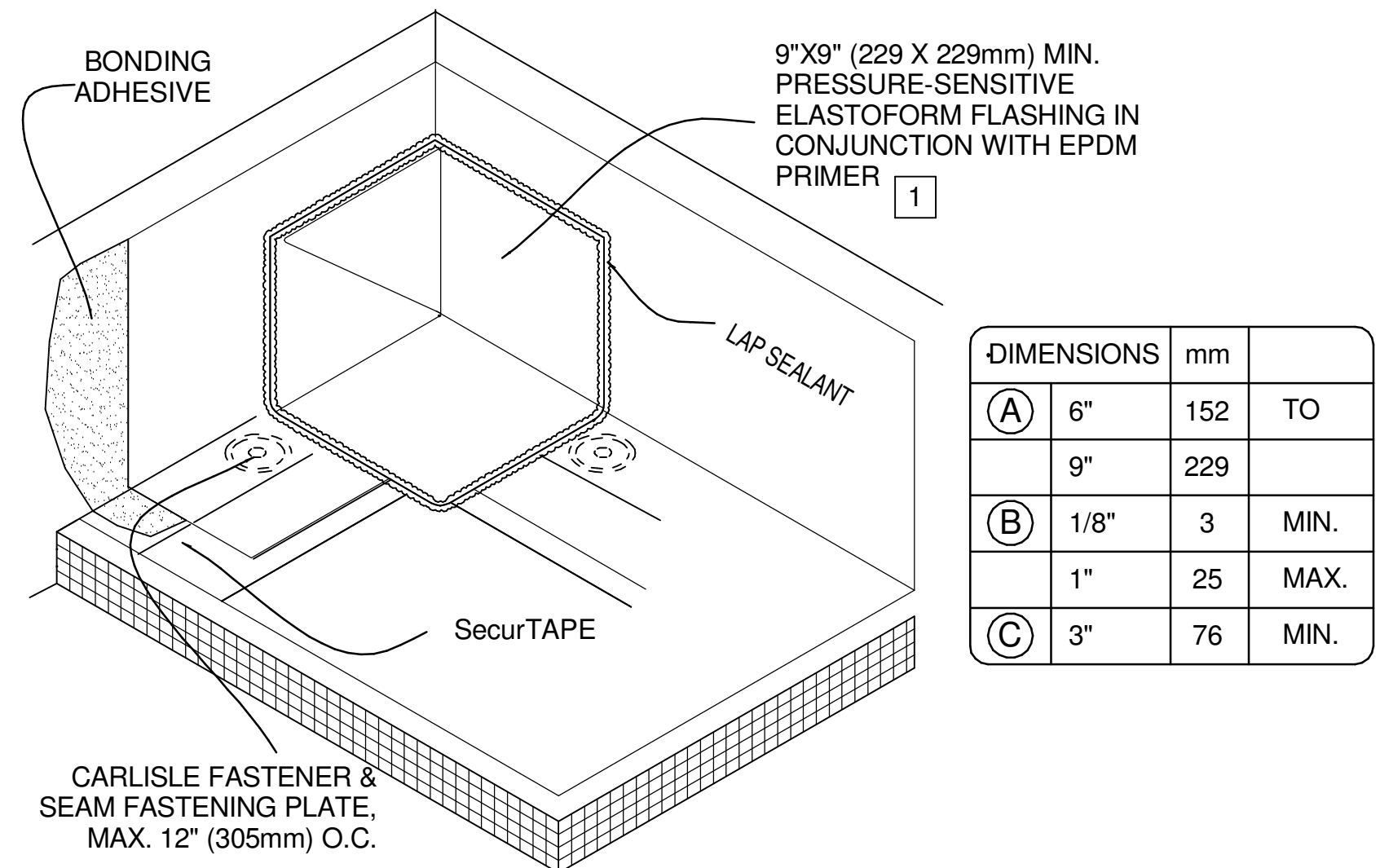

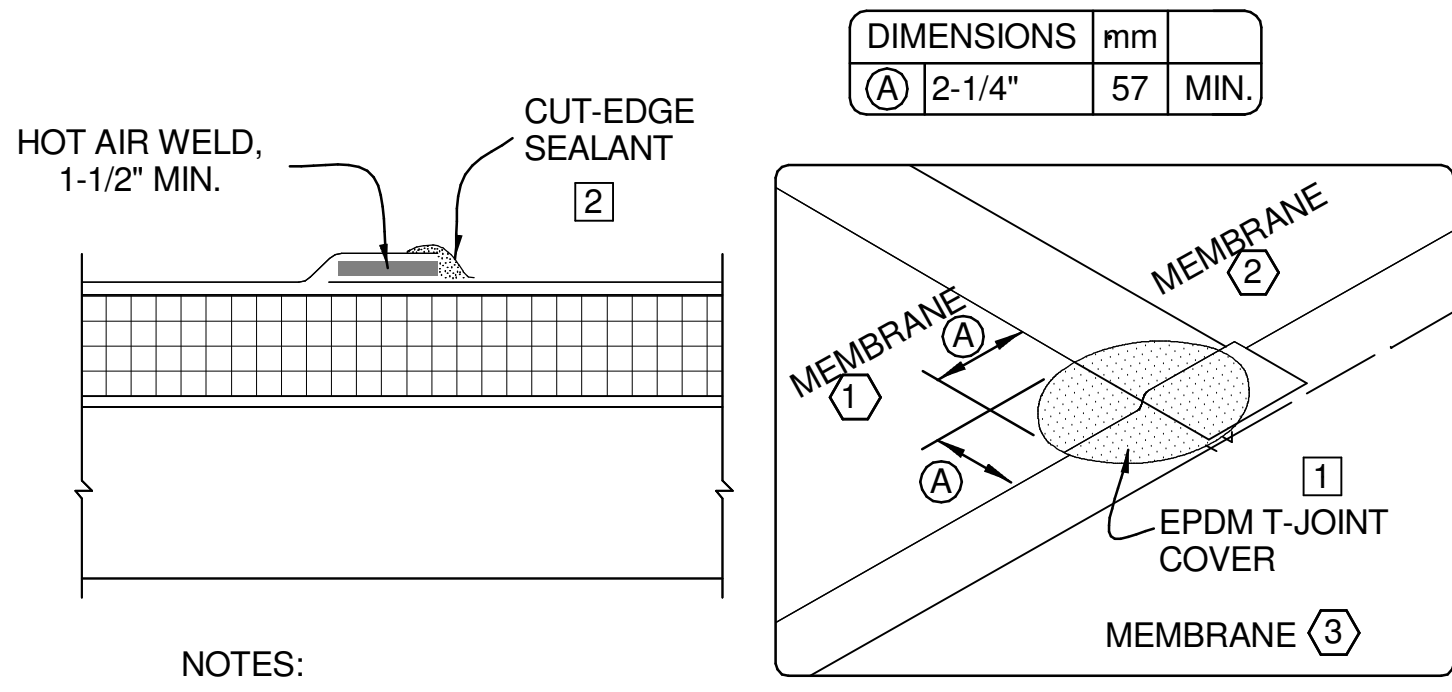

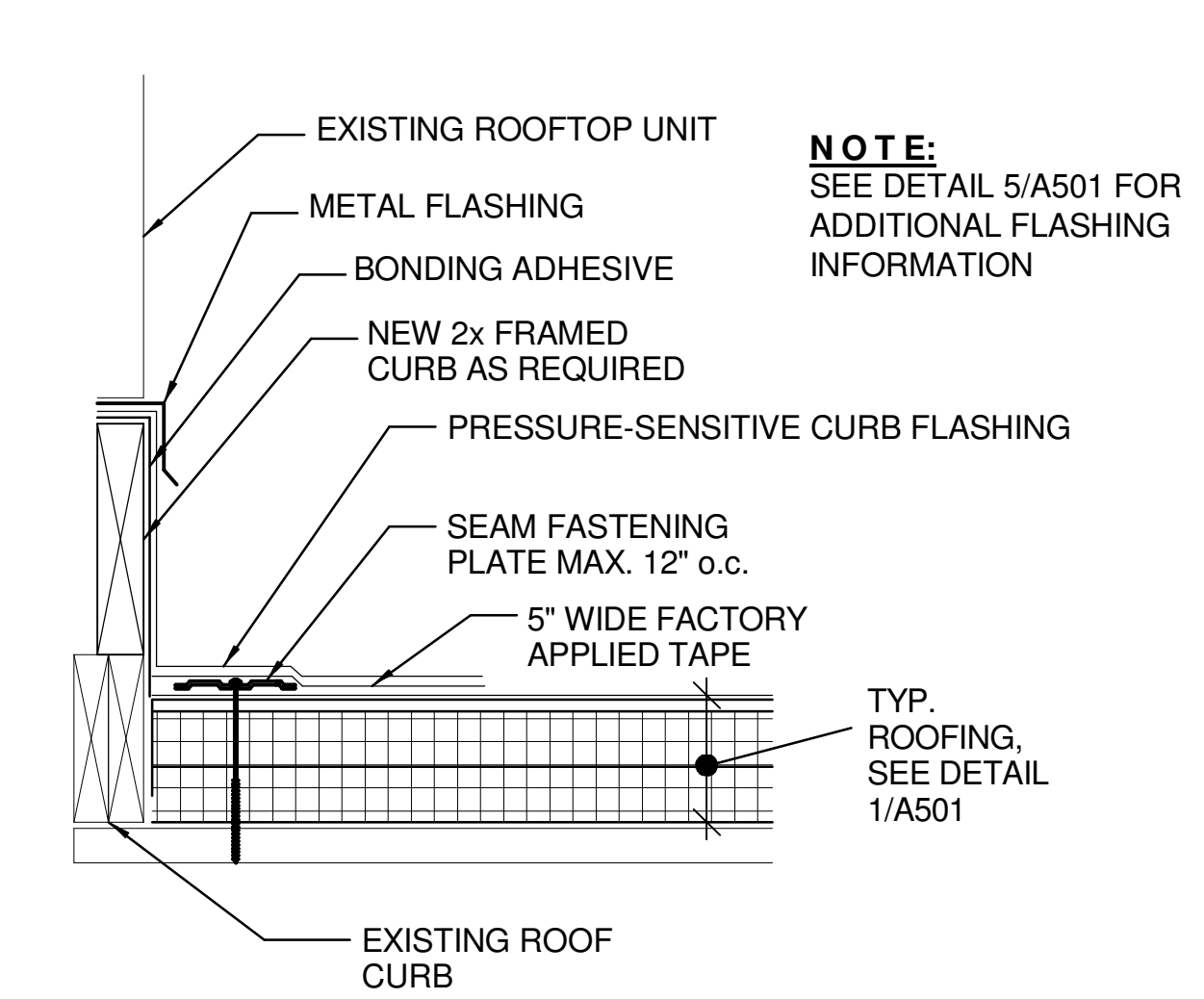
13 EPDM MEMBRANE SPLICE DETAIL

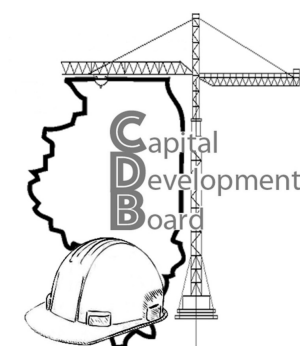

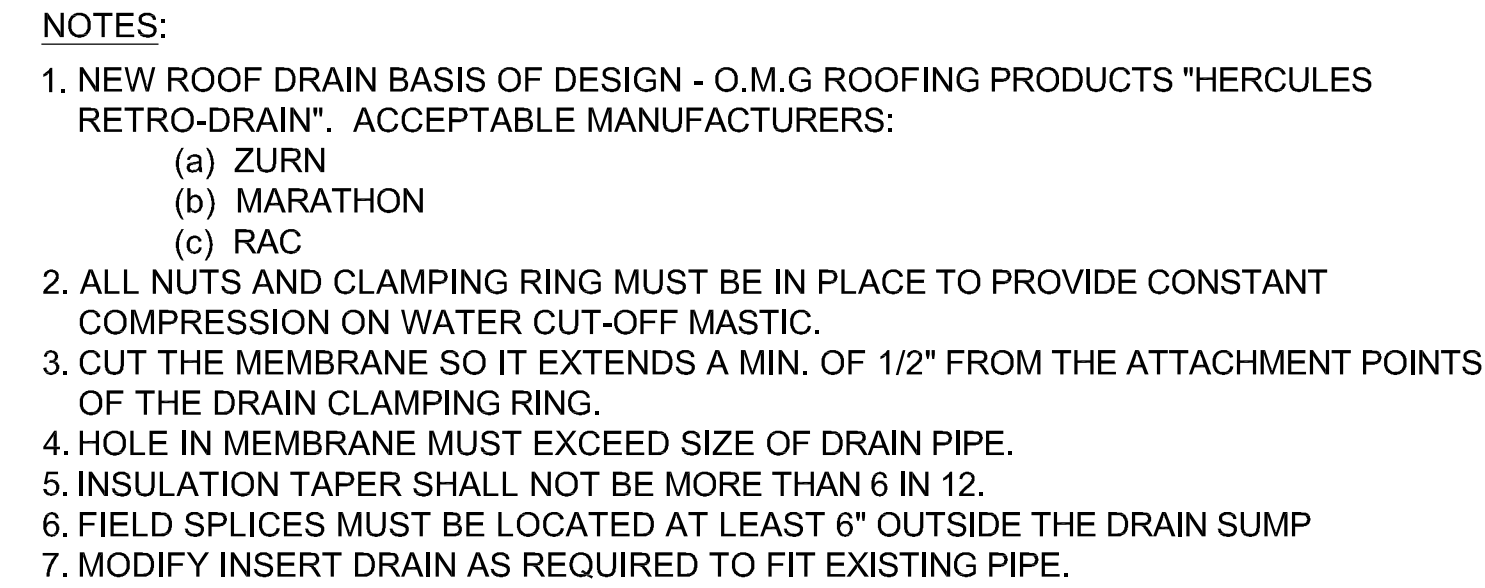
