#### Base Bid "A" - General Construction Work

#### Alternate Bid "A-2" – New Radiant Heating System

Provide and install new radiant heating system in the exterior concrete ramp as shown on the drawings.

- Sealed bids for the work will be received from interested contractors no later than 2:00 p.m. prevailing time, Thursday, January 24, 2019 at the office of Architechnics, 10th floor, 510 Maine Street, Quincy, Illinois, 62301. The bids will be privately opened.

A deposit of \$100.00 will be required for use of the paper plans and specifications for bidding purposes. Only one paper set will be available per plan holder. A non-refundable fee of \$50.00 will be charged for access to the digital drawings and specifications. Bidders who order paper or digital plans and specifications will be listed on the plan holders list.
- Any and all addenda including the plan holders list will be available from the Architechnics website, www.architechnicsinc.com. All those listed on the plan holders list will be mailed any and all addenda.
- Deposits will be refunded in full, only to those contractors who submit a bona fide bid and to any plan holder who returns the bidding documents to the architect's office within ten (10) days following the bid opening date. Office prior to ten (10) days following the bid opening date.
